The President has been pleased to approve the up-gradation of the following clerical / Auditors posts as detailed below w.e.f. 01-07-2007:-

4.	Assistant/Head Clerk	BPS-11	BPS-14
5.	Senior Auditor	BPS-11	BPS-14

The incumbents of the up-graded posts will also stand upgraded and their pay will be fixed at the stage next above their basic pay in their lower pay scales.

- The President has also been pleased to approve that employees from BPS 1 to 4 would move one scale up in the pay scales w.e.f. 1st July, 2007.
- The Establishment Division will amend the recruitment rules of the ministerial posts, whereas amendments in the recruitment rules of other posts listed at Para 1 above shall be made by the concerned Ministries / Divisions / Departments in consultation with the Establishment Division.
- As a special dispensation, the annual increment falling due on 1st December, 2007 shall be admissible to the above mentioned employees in the upgraded pay scales.
