UPGRADATION- POSTS OF SUPERINTENDENT, ASSISTANT SENIOR CLERK,  
JUNIOR CLERK AND CLASS-IV EMPLOYEES IN ATTACHED DEPARTMENTS/  
SUBORDINATE OFFICES IN BALOCHISTAN.

The Government of Balochistan is pleased to upgrade specific nomenclature of posts in Attached Departments / Subordinate Offices in Balochistan with immediate effect as per following terms & conditions:-

- (i) The posts of Superintendent (B-16) are hereby up-graded in (B-17) in person to the incumbents after (3) three years satisfactory service as Superintendent (B-16) in all Attached Departments / Subordinate Offices in Balochistan.

**Note:** This upgradation will not be admissible to those Superintendents (B-16), who have already availed the benefit of B-17 w.e.f. 01-07-2011 under circulars No.FD(R-I)III-79/D.A./2011/1590-1710 dated 23-06-2011 & No.FD(R-I)III-79/D.A./2011/3971-4091 dated 25-11-2011 as well as those Superintendents (B-16) who were promoted to any other nomenclature in (B-16) and granted the benefit of (B-17) w.e.f. 01-07-2011 vide circular No.FD(R-I)III-79/D.A./2011/4092-4212 dated 26-11-2011. However, these circulars shall stand withdrawn from the date of issuance of this circular.

- (ii) All posts of Assistant (B-14) are hereby up-graded in (B-15). Henceforth, the posts of Assistant (B-15) will be placed in (B-16) in person to the incumbent after (10) ten years satisfactory service as Assistant (B-15) in all Attached Departments / Subordinate Offices in Balochistan.

**Note:** In case of regular promotion of Assistant (B-15) to Superintendent (B-16), the services of incumbent shall be regulated under the condition laid down at para-1 (i) of this circular.

- (iii) The post of Senior Clerk (B-09) are hereby up-graded in (B-11) in all Attached Departments / Subordinate offices in Balochistan.

- (iv) The post of Junior Clerk (B-07) are hereby up-graded in (B-09) in all Attached Departments / Subordinate Offices in Balochistan.

- (v) All posts of existing Class-IV employees are hereby up-graded one step higher in person to the incumbents in all Attached Departments / Subordinate Offices in Balochistan.

**Note:** Creation of Class-IV posts and fresh appointments shall remain as same as before issuance of this circular.

2. All the Attached Departments / Subordinate Offices shall ensure framing / revision of Service Rules of the above categories of employees in consultation with S&GAD through their Administrative Departments accordingly.
