OFFICE MEMORANDUM

Subject:- **OPTION FOR GRANT OF CASH MEDICAL ALLOWANCE/MEDICAL FACILITY TO THE WAPDA PENSIONERS.**

Ref:- This Division's O.M No.F.O(B&F)/3-42/Vol-8/1681-1780 dated 04.07.2013.

The Authority as a result of bipartite meeting with Labour Union (CBA), has been pleased to allow the pensioners to exercise their option for the medical facility or Cash Medical Allowance at the following rates:-

- (i) Pensioners who retired/will retire in BPS 1-15 @ 25% of Net Pension drawn.
- (ii) Pensioners who retired/will retire in BPS 16 to 21 @ 20% of Net pension drawn.


The Medical Allowance in respect of the above mentioned pensioners will be admissible at the level of net pension as on **30.06.2012**.

The Wapda employees retiring on or after 31.12.2013 shall be allowed Medical Allowance at the above mentioned rate of the net pension which shall remain frozen at the same level.

Such option will be submitted to the Incharge of Pension payment office, who will enter the amount of Medical Allowance on the PPO Book of the pensioner concerned.

The recipients of the said Cash Medical Allowance will however, be eligible to avail of Medical Facility at Wapda Hospital/Dispensaries as otherwise admissible to serving employees drawing Cash Medical Allowance. Further, the existing facility of re-imbusement of amount spent on account of purchase of medicines by the pensioners and local purchase of medicines by Wapda Hospital/Dispensaries for such outdoor patient will be discontinued.

The O.M. dated 04.07.2013 shall be deemed to have been superseded.

OFFICE MEMORANDUM

Subject: GRANT OF CASH MEDICAL ALLOWANCE TO THE RETIRED EMPLOYEES LIVING IN FAR FLUNG AREAS AFTER RETIREMENT.

The authority has been pleased to accord approval to allow Cash Medical Allowance at the following rates to those retired employees who are living in far flung areas and Districts after retirement where no Wapda Hospital, Fortified Dispensary or Basic Dispensary/Health Care facility exists.

- (i) Pensioners who retired/will retire in BPS-1-15 @ 25% of net pension drawn.
- (ii) Pensioners who retired/will retire in BPS-16-21 @ 20% of net pension drawn.

The medical allowance in respect of above mentioned pensioners will be admissible with immediate effect at the level of its admissibility as on 30.06.2012.

The payment of Cash Medical Allowance to such retired employees will be regulated on the basis of the offices, located in far flung areas. From where their pension is disbursed.

It will be subject to the exercising of option by the retired employees to draw Cash Medical Allowance in lieu of medical facility. Such option will be submitted to incharge of pension payment office who will enter the amount of Medical Allowance on the PPO Book of the employee concerned.

The recipient retired employees will however be eligible to avail medial facilities at Wapda Hospital/Dispensaries as are admissible to serving employees drawing Cash Medial Allowance.

The above allowance will not be admissible to other retired employees.


