OFFICE ORDER

Decision to allow electric connection to mosques on the basis of service rental instead of payment of lumpsum cost of service estimate was conveyed vide this office circular letter No.896-906/GMD/Tariffs/G-157 dated 27-04-1986. Subsequently, this concession was also extended to Churches, Temples (Mundars) and Gurdwaras vide this office circular letter No.3869-37/GMCS/D(R&CP)/WM-321 dated 21-5-92.

2. In order to avoid misuse of this facility it has been decided that electric connection to a mosque, church, temple (mundar) and gurdwara will be permissible on rental basis only at places where WAPDA's Distribution Network already exists. Secondly, provision of electric connection will be subject to the condition that connection is justifiable in financial terms as per the prescribed formula.

3. You are, therefore, requested to ensure that electric connections to mosques, churches, temples (mandars) and gurdwaras are approved on service rental basis only at places where WAPDA's Distribution Network exists at the place of connection applied for and that the connection applied for is 'financially justified' and not otherwise.
