

No.18 of 1980) and all others powers enabling him in this behalf, the Chief Commissioner ICT, Islamabad, has been pleased to fix the following monthly emoluments for part time employees and rates of daily wages with immediate effect :-

(i)	Daily Wages for Skilled Worker.	Rs. 700/- per day
(ii)	Daily Wages for Semi-Skilled Worker.	Rs. 410/- per day
(iii)	Daily Wages for Un-Skilled Worker.	Rs. 350/- per day
(iv)	Monthly Rates for Part Time	Rs.4,600/- per month

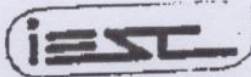
